

BYLAW NO. 11/88

A BYLAW OF THE TOWN OF LUMSDEN AUTHORIZING COUNCIL TO ENTER INTO AN AGREEMENT FOR THE ESTABLISHMENT OF A MUNICIPAL MUTUAL AID AREA

WHEREAS provision is made in the Urban Municipality Act, 1984, Section 175 enabling Council to enter into agreements with any person or association with respect to any matter within the jurisdiction of the Council;

AND WHEREAS the Council of the Town of Lumsden deems it expedient to enter into an agreement for the purpose of establishing a Municipal Mutual Aid Area;

NOW, THEREFORE the Council of the Town of Lumsden in the Province of Saskatchewan enacts as follows:

- (1) That the Agreement hereunto annexed and marked as Schedule "A" to this Bylaw and which is deemed to be a part of this Bylaw, being an Agreement
