Unfinished Business

Pool Committee Feedback

The Pool Committee met to discuss the roles and responsibilities of the Committee, should a pool become a reality. The Committee does not seek to manage a pool, such as the manner in which the Lumsden Sports Association operates the arena. The Pool Committee was pleased with the potential pool location in RiverPark. The Committee is more than willing to fundraise. In the absence of a business plan, the Town has not yet granted approval for the construction of a pool. The Community Coordinator will provide guidance so that the Pool Committee can assemble the required information for Town Council's consideration.

Seventh Avenue Washrooms

There is a group willing to fundraise toward the installation of washrooms at the Seventh Avenue ball diamond/park. There are currently two porta-potties on site. On-going cleaning of the proposed washroom facility is a concern as it would require daily cleaning. Septic hauling would be an additional operating cost, if not connected to the sanitary sewer system. The Community Coordinator will investigate the price of other porta-potty options.
