Reports of Committees

Environmental/Public Health and Welfare Committee - Councillor Brennan

- Upcoming meeting with EPO to discuss a Transfer Station for the Town of Lumsden
- With regard to landfill decommissioning; the Committee agreed that a geosynthetic liner is the preference, due to a lack of appropriate clay on site
- Once the landfill is decommissioned, the intention is to operate a Transfer Station and to continue to offer the disposal of household waste (in large bins), recycle centre, clean wood disposal and metal disposal. Household waste will continue to be collected by Town staff. The Transfer Station will continue to be available to residents of the RM of Lumsden.

Water & Sewer Utility / Solar Committee - Councillor Phillips

- Dodds' water system (607205 Saskatchewan Ltd.) is operating well since their capital investment
- Waste Water Treatment Facility testing results are well within acceptable regulated standards.

Water Leak Rebate Policy

Water & Sewer Connection Fees

Yard Waste Paper Bag Program Moved by: Mayor Matheson Seconded by: Councillor Phillips

"That we recommend Council approve the purchase of paper yard refuse bags intended for resale, in bundles of 10 for \$10 (including taxes), to Lumsden residents;

That Town staff no longer pick up yard waste in plastic bags;

That Town staff no longer pick up yard waste left in loose piles; and

That Administration promote the use of paper bags and ensure residents are aware that plastic bags and loose piles will no longer be collected during the fall yard waste pick-up."

Recycling Collection Contract Expiring
