Part 1 – Mail-In Ballots

The Town of Lumsden is offering an opportunity to vote by using a Mail-In Ballot. To request a Mail-In Ballot, you must submit a ‘Voter’s Registration Form’ and a ‘Declaration of Person Requesting the Mail-In Ballot’. These documents, are provided below and must be submitted no later than **Wednesday, April 22, 2026**. Part 2 – Eligibility to Vote

36(1) A person is eligible to vote in a municipality who, on election day:

- (a) is a Canadian citizen;
- (b) is at least 18 years of age on or before election day; and
- (c) in the case of an urban municipality has resided in Saskatchewan for at least six consecutive months immediately preceding the day of the election and:
 - (i) has resided in the municipality, or land now in the municipality, for at least three consecutive months immediately preceding the day of the election; or
 - (ii) is the owner of assessable land in the municipality, or land now situated in the municipality, for at least three consecutive months immediately preceding the day of the election.
